### **Platte River Bridge Construction**

Rich Collins, County Commissioner, and Steve Backowski, County Highway Dept., were present to discuss the construction on the Platte River Bridge on East Centre Street. # <u>Public Hearing – Outdoor Recreation Grant</u>

Mayor Lauer called the Regular City Council meeting back to order.

Verley moved to adopt Resolution 3-6-12-4, Item #7 of the DNR Outdoor Recreation grant application, a Resolution stating the City of Royalton is the legal sponsor for the Splash Park Project and authorizing Mayor Lauer to apply to the Department of Natural Resources for funding of this project on behalf of the City of Royalton, 2<sup>nd</sup> by Libke. Put to a vote with all members voting aye. Motion carried.

# **Public Input Session – Ordinance #21**

No public input. Tim Majaski, Planning & Zoning, reviewed the proposed amendments to the Burning Ordinance #21. More amendments will be made and brought back to the April 3, 2012 meeting.

### **City Test Well Location**

Mayor Lauer reported more appraisals are coming in and when they are done she will call for a Special City Council meeting so the Council can choose a site for the test well.

# 3<sup>rd</sup> Street Project

Les Mateffy, Mateffy Engineering, reviewed the 3<sup>rd</sup> Street estimate and proposal. It was decided to have the Mayor send letters to the property owners and invite them to meet with two Council Members; Tim Majaski, Planning and Zoning Chair; and Les Mateffy, City Engineer.

Haberman moved to adopt Resolution 3-6-12-1, a Resolution Establishing Procedures and Policies Relating to Post Issuance Compliance Under the Internal Revenue Code Upon the Issuance of Governmental Bonds, 2<sup>nd</sup> by Doty. Put to a vote with all members voting aye. Motion carried.

### **Resolution 3-6-12-2**

Libke moved to adopt Resolution 3-6-12-2, a Resolution re-establishing the precinct boundaries for the portion of Benton County that lies within the City limits of Royalton, 2<sup>nd</sup> by Verley. Put to a vote with all members voting aye. Motion carried.

# **City Hall Cleaning Quotes**

Mayor Lauer reported that the previously hired cleaning person has decided not to continue to clean city hall, therefore, the City needs to hire someone else. After reviewing the other quote received, Verley move to hire BK Commercial Cleaning at \$164.65 plus tax, per month, with extra cleaning as needed, 2<sup>nd</sup> by Libke. Put to a vote with all members voting aye. Motion carried.
